# Introduction

- It is an **annual** certification program.
- Targets those charged with governance and decision makers in any organization.
- The core of the process is the Corruption Prevention Management Test (CPMT).

# Corruption Prevention Management Test (CPMT)

- The CPMT is an online test authored by and copyrighted to The AACI.
- Quantifies and measures relevant corruption prevention knowledge competencies of the board members, senior management and employees.

## Corruption Prevention Management Test (CPMT)-(Cont.)

- Know your organization corruption risks: Insightful, Effective, and Indicative.
- Know your employees.
- Available only to organizations; not available to individuals.

# Certification Objectives

Enables those charged with governance to:

- **Evaluate and measure** relevant corruption prevention knowledge competencies of the board members, senior management and employees.
- **Identify** the strengths and weaknesses of the entity's corruption prevention knowledge that is necessary for preventing fraud and corruption.

## Certification Objectives (Cont.)

- **Select appropriate responses** to address identified corruption prevention knowledge weaknesses.

# CPMT Tested Fields

- More than 80% of the questions cover the following fields:
  - Anti-fraud and corruption
  - Corporate governance
  - Internal control
  - Anti-bribery management systems
- The rest of it *touches* on the following:
  - Accounting
  - Auditing
  - Management and ethics

# CPMT Attributes

- Number of questions: **30**
- Type of questions: Multiple choice and true/false
- Has a time limit of: **00:45:00**
- Number of attempts allowed: **1**
- Must be finished in one sitting. You cannot save and finish later.
- Questions displayed per page: **1**
- Will not allow you to go back and change your answers.
- Will not let you finish with any questions unattempted.
- Has a pass mark of: **80%**



# Sitting For The CPMT

- Obtain from your organization
  - Its CPMT designated link
  - Your CPMT password, and
  - The test availability
- Have an internet connection, log in, and have fun.
- ALL the well-known browsers work fine.
- Desktop, laptop, tablet (i.e iPad) or smart phone (i.e. iPhone).

## Sitting For The CPMT (Cont.)

- When you PASS it, download your certificate of achievement.
- When you finish it, have immediate feedback for each incorrect answer.

# Certification Output

- CPMT Certificate ([sample copy](#))
- CPMT Report ([sample copy](#))
- More detailed reports

## Certification Output (Cont.)

More detailed reports show the following:

- Name of the organization
- List of the CPMT takers first and last names
- The test taker's
  - Final score
  - Number of questions presented from each section and number of correct answers in each section.

## Certification Output (Cont.)

- Summary report showing the following aggregate score for:
  - ALL test takers in the CPMT
  - Each section of ALL test takers in the CPMT
- CPMT sections are: Corporate Governance, Internal Control, Anti-Fraud and Corruption, Auditing, Accounting, and Management and Ethics.

## Passing Score

- An organization's aggregate score of 80% or more is excellent.
- There is **not** pass or fail score for an organization.
- A member of an organization sitting for the CPMT should score 80% or more to have a PASS score.

# How Long It Takes

- Less than one month
  - from beginning to have the CPMT Certificate, CPMT Report, and other detailed reports.



## You Do Not Need It IF !

- Have you ever quantified your organization's fraud and corruption exposure?
- Even if the answer is yes, change guarantees that there may have been changes in your employees' competencies since then.
- Act today. Find out where your organization stands.
- Remember: Knowledge is power when you have it *and* you use it.
