# The CPMT Online Test Objectives and Contents

The objectives of the test are (1) evaluating and measuring relevant corruption prevention knowledge competencies of the board members, senior executive management and departments' heads (employees), (2) identifying the strengths and weaknesses of XYZ Company's corruption prevention knowledge that is necessary for preventing fraud and corruption, and (3) selecting appropriate responses to address identified corruption prevention knowledge weaknesses. Internal control, anti-corruption, anti-bribery, and corporate governance constitute at least 75% of the test. Moreover, accounting, auditing, and business ethics constitute not more than 25% of the test.

## Those Who are Charged with Governance's Responsibility

Those who are charged with governance are responsible for providing the Exam Unit with complete lists of all the board members, senior executive management, and departments' heads of XYZ Company who will sit for the test. They are responsible for the administering their employees to sit for the test.

The Exam Unit Responsibility

Our responsibility is to manage and report on the test of XYZ Company. Upon its completion of the test, we issue XYZ Company a CPMT certificate and other detailed reports. The CPMT certificate is valid for one fiscal year from the date of the test completion. This validity may be substantially impaired when there is a significant change in the composition of the board members and / or senior executive management whichever is shorter.

We are not responsible for validating the completeness of the lists of test sitters of XYZ Company. When one or more of the board members and / or senior executive management and / or 5% of departments' heads do not sit for the test, we will mention this material fact in this report.

We do not opine or provide any assurance with respect to the effectiveness of the Company's internal control, its anti-corruption policy (if any), its anti-bribery management system (if any), or its code of ethics (if any).
